






New Blair Hall Pass Policy

Grading Policy

At Montgomery Blair High School, we believe that the MCPS Grading and Reporting policy emphasizes teaching toward every student's mastery of learning goals, reteaching and reassessing when students do not demonstrate mastery of these goals, informing instructional decisions, and gathering data from assessments for teacher, team, PLC, and school reflection. For this reason, students must complete all assigned work promptly to help facilitate the instructional process.

Other classroom policies that will help guide student behavior and engagement this year.

Can I submit late work?

It is important to complete work on time to be ready for classroom activities and future learning. The due date is designed for you to receive feedback in a manner that will prepare you for larger assignments and class discussions. Work turned in after the deadline will earn a 0%, but will still receive feedback. Deadlines are assigned up to 10 days from the due date. All students with accommodations (50% or 100% extended time) will have due dates and deadlines reflective of their approved accommodations. These are communicated via CANVAS on the assignments, or on paper assignments.

Can I redo work if I don't like the grade?

Yes! Students will have opportunities to reassess all formative tasks and at least one summative task per quarter. The goal of reassessments is to support students in their ability to demonstrate mastery of course standards. Students should take advantage of academic support before reassessments. In order to reassess an assignment, students must have completed the assignment initially. All re-assessable tasks will be noted with an "(R)" at the beginning of the assignment name in CANVAS and Synergy. All reassessments must be completed within two weeks of the assignment being returned.

What should I do if I'm absent from class?

From the Blair student handbook, "Upon returning from an absence, students have three days to make-up work missed during a student's absence. It is the student's responsibility to find out what work they missed and to make arrangements for completion within the three days following their return to school. For long-term assignments assigned before an absence, presentations, etc. the teacher and student should work out appropriate times to make up the work. Students should check CANVAS to access any assignments that might have been assigned during the absence and should check in with their teacher to get papers and notes that were missed.

What happens if I'm caught cheating in this class?

Academic dishonesty, including plagiarism and/or the use of AI to complete all or portions of an assignment, is not acceptable in classrooms. The first instance will result in the student being allowed to redo a similar assignment WITH their teacher, or the department Resource Teacher during the student's lunch period. The second instance will result in a 0% and communication with the student and their family. Any additional instances will result in a 0% and a referral to administration. Students should refer to the Code of Conduct to review additional consequences that occur for violating systemwide rules regarding academic dishonesty.

What textbook will we be using this year?

We will use an open source college-level American government textbook created by professors at Rice University. <u>American Government 4e</u> will be provided to students electronically through MyMCPS Classroom. Each week, students will receive an assignment from this textbook to read as homework. This work will reinforce what we have learned in class and provide further study of concepts, vocabulary, and examples.
